Dear Landowner,

This year certain members of the GLA Board decided to make an issue and demanded <u>after the fact</u> to change the way to accept nominations. In short, they have demanded for the entire board to receive the nomination from each candidate. In effect, they were changing horses in mid-stream. In the past the Administrator received nominations whether through the info account, mail or fax. The forms used this year were exactly the same as used last year. There were no changes from prior years regarding the way nominations were received. This year the playing ground was changed. A last minute change was made to request the entire Board, not the Administrator to receive the nominations on the date they were due. This was an attempt to knock out certain nominees. The Administrator's mother passed away and asked the president and secretary to pick up the mail. All nominations were filed with the Administrator in a timely way on September 25, 2020 by 500 PM. The administrator emailed all nominations to the board the very next day. With a 6 to 5 vote the Board determined that the nominations were a day late and therefore were disqualified.

A committee of landowners was formed to sponsor disqualified candidates to run for the Glastonbury Landowner Board. They are running now as write-ins.

The write-in candidates are representatives of a corporation, association or other legal entity. We have almost always had legal representatives on the board. This year we had Jean Carp, Ed Dubrowski and Andrea Sedlak, all were reps for legal entities and John Carp as Ombudsman was also. This was done pursuant to GLA By-laws, Article V, para. G. and is legal.

This committee of landowners is asking for your write-in vote. These three candidates were removed from the ballot. Harmony is needed on the Board.

DELIVERY: Individuals designated as proxies must present the form or proxy appointment documentation in person at the sign-in table at the Annual Election Meeting on November 14, 2020, between 10:00 a.m. and 12 noon.

RESTATED BYLAW ARTICLE V.G. Designation of Representatives. 2. Proxy.

Proxy. Any Member can appoint a proxy representative to vote for their Membership Interest(s) at any or all Annual and Special Meetings of the Members of the Association. Any Member may designate any person to vote as proxy on his or her behalf, except that proxy appointees who are also landowners themselves must be in good standing on their own Membership Interests in order to vote as proxies. Directors are not permitted to act as proxy appointees. The appointment may be submitted on the "Proxy Designation Form" or by using another format that fulfills the validity requirements. To be valid, a proxy must be in writing, dated, executed by the Member of record or legal representative of such Member and filed with the authorized election staff at the appointed time for a meeting. Such proxy shall be effective and remain in force until voluntarily revoked, amended or terminated by operation of law, until the expiration of one year after its execution or until the date of the next Annual Meeting after the proxy was used at the previous Annual Meeting. A proxy is revocable by the Member appearing in person and voting before his or her proxy representative votes. The Association shall continue to recognize a proxy that has not expired until it receives notice of such revocation, amendment or termination.
