COMES NOW the Plaintiff,Mark Seaver, respectfully states the following:						

1. The named individuals are the President (Newman Brozovsky) and Secretary (Charlotte Mizzi) of the GLA board of directors. These two officers have failed in their duty conduct GLA procedures in a timely and respectful manner or to provide oversight of the GLA administrative assistant, Karleen McSherry. This failure of leadership is demonstrated by the fact that the plaintiff, Mark Seaver, who was the GLA Treasurer from December 3 2018 until November 4, 2019 continued to receive in his personal email address, every voice message recorded for the GLA Treasurer from the time of his resignation as treasurer on November 7, 2019 until March 11, 2020. This time period also includes 3 months starting on December 9, 2019, when the new Complaint Page 1

GLA board of directors were seated and appropriate changes to the GLA email and voicemail systems should have been taken care of. Every one of these 39 voice mail messages should not have been delivered to the plaintiff since he was no longer the GLA Treasurer after November 7, 2019 and no longer a member of board of directors after December 9, 2019. He asked repeated, via 20 emails, sent to the entire GLA board of directors, initially nicely and eventually not nicely, to have this problem remedied starting on December 17, 2019 and continuing through March 11, 2020, a period of over 3 months. Dealing with these 59 emails caused the plaintiff considerable upsetment when each email was received or sent and especially when his requests to fix the problem were ignored. This upsetment caused the plaintiff suffered numerous sleepless nights due to the frustration of not being able to get this simple problem fixed. The plaintiff also responded directly to several of the landowners who had left these voice mails out of his sense of duty to the Glastonbury community because it was not clear that the GLA board of directors was going to respond to these requests for information on the landowner's assessments. The list of emails received and the plaintiff's responses to the GLA board of directors appear in Attachment #1, which is copied from the plaintiff's email account.

THEREFORE the Plaintiff respectfully asks this court to grant the following:

- 1. Compensation of \$200 for each of the 59 emails sent and received due to the time and energy invested in reading and responding either to the GLA board of directors or to the landowners who left the message for a total of \$11,800.
- 2. Punitive damage of \$800 for each of these 59 emails, due to the abject failure of the GLA board leadership to provide the attention needed to fix a simple problem for a total of \$47,200.
