Administrator's Note: Candidate Kathleen Rakela was found to be in violation of Glastonbury Covenants by the GLA Board at their October 9th meeting. Her candidacy was declared "invalid".

Candidate forms were required by the GLA to be submitted by 12 noon on September 13th, 2017. In order to qualify as a candidate a landowner had to be "in good standing" at the same time. "In good standing" means that the landowner cannot be in violation of any covenants.

About one year ago Kathleen Rakela sub-divided one of her parcels and did not notify the GLA. The Covenants require that landowners notify the GLA of any changes in ownership. After Kathleen Rakela's candidate application was accepted a routine audit of parcels revealed that she did not notify the GLA Board of her year old sub-divided parcel. A letter was sent out and Kathleen responded by filling out a form. She then sent the completed form to Minnick Management; not the GLA. The form had not arrived at either place by the time of the October 9th GLA Board meeting.

It was determined by the GLA Board that Kathleen Rakela had not notified the GLA Board by September 13th at 12 noon of her sub-divided land. That lack of action on her behalf put her in

Let's see if I get this correctly. Rakela has developed a history of ignoring the covenants that she professes in her bio to uphold. In the 2016 annual election for directors she was the cause for the board to require a recount of votes: <u>link</u>. In this 2017 election cycle she decides, or is encouraged, to run for the board but is not "in good standing" as the GLA covenants require at the time of filing her application to run. Consequently the board disqualifies her candidacy. After the fact, she corrects the situation so that she is in good standing, and threatens a lawsuit if the board does not permit her to run. The board, led by Election Committee chair and board secretary Charlene Murphy, decides to postpone the scheduled annual meeting from November 11 to December 2 to allow Rakela to run as a write-in candidate: <u>link</u>.
